The **Council of Superior Court Clerks of Georgia** is a state agency established by law and funded through a state appropriation to further the improvement of the superior courts in the administration of justice, to assist the superior court clerks in the execution of their duties, and to assist in the training of superior court clerks. The Council is comprised of all 159 Superior Court Clerks and is the official representative of superior court clerks to other state agencies in Georgia. The Council is also responsible for administering grants and other projects as assigned by its members and the Georgia General Assembly.

The **Superior Court Clerks' Association of Georgia, Inc.** is a professional organization comprised of elected Superior Court Clerks and associate members. The association was established in 1967 and is funded through dues paid by its members. The association's functions include political advocacy, legal appeals and promoting professionalism in those who serve as Superior Court Clerk.

Both the Council and Association are governed by executive boards elected by their membership.

The **Georgia Superior Court Clerks' Cooperative Authority** was established in 1993 with the legislated mandate of implementing and administering a statewide central index for UCC filings. Later projects include administering a statewide index for real estate and personal property records, maintaining the central database of notaries public and administering a statewide database on civil case filings.

The Clerks Authority is a state authority that is self funded and is governed by a board appointed by the Governor, the Lt. Governor, the Speaker of the House and the Council of Superior Court Clerks.




